



MESSAGES FROM THE TEAM

MESSAGE FROM THE CEO AND CHAIR



Fit to Drive has had a very positive year across the range of our programs. The 2023–2024 Annual Report details these activities.

We commenced the delivery of a new road safety pilot on behalf of TAC, the Work Smart, Drive Smart program.

This program focuses on young apprentices in the construction trades.

Fit to Drive worked closely with TAC on consulting on elements of the program with key stakeholders including industry groups and Victorian based trade trainers including Apprenticeships Victoria, the Apprentices Employment Network, the Victorian Chamber of Commerce and Industry, a range of construction Unions and TAFE trainers. Together we developed effective delivery options and recruited experienced trade trainers to present the workshops facilitated by Fit to Drive. The response to initial workshop delivery has been very positive. We look forward to successfully completing the delivery of Work Smart, Drive Smart in 2024–25.

Our commitment to the on-going delivery of the F2D Workshop in schools has been another highlight. Despite the absence of state government funding in 2023–24, we successfully delivered 90 workshops, reaching 11,635 students throughout Victoria. We would like to acknowledge the on-going strong support by both Victoria Police (VicPol) and Fire Rescue Victoria (FRV) for the F2D Workshop and for their participation in delivering workshops. Presentations by VicPol and FRV, facilitated by our team aim to encourage safer choices by young people, and better road safety outcomes.

Evolution of the Green Light Initiative (GLI), continued including in the development of a discrete program focused on culturally and linguistically diverse (CALD) groups in the Victorian community. Fit to Drive successfully applied to the Department of Transport and Planning (DTP) for grant funding of the CALD GLI throughout 2024–25. This funding will allow Fit to Drive in partnership with VicPol to deliver up to 10 workshops. Fit to Drive acknowledges the support by DTP for the program and we look forward to delivering an increasing number of workshops in the years ahead.

None of these achievements however would have been possible without the dedication of the Fit to Drive team. We thank them for their commitment to improving road safety in Victoria.

We prepared for an enhancement of the board’s membership with new directors who will bring new skills including in areas such as marketing and communications, research, IT and cybersecurity and organisational governance. Fit to Drive is well positioned to maximise future opportunities in developing and delivering road safety programs in line with the Victorian Government’s Road Safety Strategy 2021–30 and to address future challenges. A key goal of our Strategic Plan is achieving sustainable on-going funding for our programs. Progress in ultimately attaining charity status will assist Fit to Drive to attract funding and in-kind support. We would also like to recognise the contribution of Libby Murphy APM, who has been both Patron and Ambassador of Fit to Drive. Libby’s dedication to road safety reflected in her support for Fit to Drive has been vital at a critical time in the Foundation’s history.


MESSAGE FROM THE PATRON

This will remain the main priority of VicPol's Road Safety Strategy 2024-2027. This also includes the consequences for irresponsible road use. Positively, survey results of teachers and students indicate the value placed on VicPol's engagement.

In 2023-24, VicPol was especially pleased to be engaged in the Green Light Initiative (GLI) with a special focus on culturally and linguistically diverse communities (CALD). The CALD GLI, developed by Fit to Drive and delivered in partnership with VicPol addresses community need focusing on disadvantaged and / or marginalised groups. The program has received grant support from the Department of Transport and Planning (DTP). I look forward to supporting VicPol's future participation. VicPol also supports, as a needed road safety initiative, the delivery by Fit to Drive of TAC's pilot program, Work Smart, Drive Smart which focuses on road safety awareness among young apprentices in the construction industry on their P plates.



MESSAGE FROM THE AMBASSADOR



FRV believes in empowering young people and building their confidence to speak out, self-advocate and to make safer choices including on the range of alternative travel options aimed at eliminating the risk of road trauma.

The F2D Workshop encourages young people to become safer road users as both drivers and passengers by focusing on personal safety, responsibility, and in assisting developing their own safety strategies. FRV collaborates with Fit to Drive and Victoria Police to bring this workshop "into life" across the range of Victorian educational settings via a vital real-life case study which is included in the workshop. The case study challenges young students to reflect on their own actions on our roads and the subsequent consequences. Survey responses indicate the positive impact of the case study on students. In the year ahead, I look forward to facilitating Fit to Drive's work by maximising and deepening FRV's engagement in the F2D Workshop and other community-based activities. I am keen to advocate for the funding of these programs as Fit to Drive's Ambassador.







EMERGENCY SERVICES

- VicPol and FRV remain engaged with the refreshed version of the F2D Workshop for 2024.
- Vicpol engagement has improved since last year, with VicPol attending 95% of F2D workshops so far for 2024. A huge improvement on the 42% attendance from 2023.
- Multiple ad-hoc VicPol training sessions have been delivered across 2023-24, targeting key areas of Victoria to increase police coverage.
- FRV have attended 100% of FRV-Zoned workshops so far for 2024


F2D MARKETING

Our marketing strategy is centred around two key objectives: (1) reaching out to education providers to promote engagement with our F2D Workshop, and (2) establishing collaborative partnerships with key funding stakeholders.

Before the new term approaches, our coordination team contact schools through a "hot-warm-cold" approach, with the aim of making approximately 15-20 cold calls per day, followed by email. Additionally, we utilise social media and existing networks with Councils and RoadSafe to promote the program.

The "hot-warm-cold" system is defined as follows:

- Hot: schools booked within the past 12 months
- Warm: booked within the last 2 years
- Cold: booked more than 3 years ago.

GLI REACH

We are able to increase our coverage of CALD communities with our targeted GLI, through obtaining a Community Road Safety Grant of \$10000. This grant will cover the 2024-25 period, and is expected to fund up to 10 GLIs. Through our continuing partnership with AMES, we expect to be able to deliver the CALD GLI at different campuses across Victoria.

Through partnership with City of Melton, we have delivered 2 GLIs, and solidified our MOU to have continuing funding of GLI in this area.

A community grant from the City of Melbourne has allowed us to fund multiple GLI sessions in this LGA.

The team made extensive efforts aimed at targeting telemarketing directly to council community engagement officers

C) DELIVER A WORKPLACE ROAD SAFETY PILOT PROJECT



- Secured a signed contract for delivery of the pilot. In addition, we successfully negotiated the extension of the contract to cover the additional scoping period in early 2024.
- We coordinated the acquisition of a range of workshop resources, including the purchase of a double axel trailer, and hiring of a utility vehicle and van. Additionally, we organised the vehicles to be wrapped in Work Smart, Drive Smart logos.
- Further, Fit to Drive recruited and hired trade facilitators for the program, as well as assisted in their training and development.

C) DELIVER A WORKPLACE ROAD SAFETY PILOT PROJECT



- Fit to Drive worked closely with TAC on consulting on elements of the program with key stakeholders including industry groups and Victorian based trade trainers such as Apprenticeships Victoria, the Apprentices Employment Network, the Victorian Chamber of Commerce and Industry, a range of construction Unions and TAFE trainers. In addition, Fit to Drive has been fundamental in facilitating the uptake and delivery of the program via industry stakeholders, well equipping us with industry contacts to expand the uptake of the program.
- We were directly engaged in the project scoping and pilot material review at Box Hill TAFE, across February to June 2024. In June, we commenced pilot delivery and booked prospective cohorts to deliver to throughout 2024. This booking system has been seamlessly incorporated into our ecosystem via our existing system used for F2D Workshop and GLI bookings.

D) DIVERSIFY FIT TO DRIVE PROGRAM OFFERINGS



F2D WORKSHOP

Trailed a modified format of F2D Workshop, aimed at streamlining and shortening the program and reducing costs. These modifications include enhanced role for VicPol and FRV in the delivery of the workshop.

CALD GLI

Rolled out a modified version of the Green Light Initiative for Culturally and Linguistically Diverse groups (CALD), which was enthusiastically received. GLI CALD focuses on foundational road knowledge and building confidence to use Victorian Roads

GIG ECONOMY WORKERS

Contributed to consultations on the Victorian Government's proposed gig economy Standards.

WORK SMART DRIVE SMART

Worked in partnership with TAC in developing a model for the delivery of the Work Smart Drive Smart program. This included extensive consultations with a range of relevant stakeholders, who are engaged in the training and employment of young apprentices in the construction trades.

Raising Awareness

A) AMPLIFY FIT TO DRIVE VOICE AND MESSAGING

- Fit to Drive has employed a dedicated **Engagement officer** for the Work Smart Drive Smart pilot program.
- Hired an external **social media contractor** to manage Fit to Drive's online presence, including Instagram, Facebook and Fit to Drive's website. The strategies included updated website profiled all team and board members, as well as spotlighting staff and workshops on social media.
- Following the Parliamentary inquiry, Fit to Drive has been included in the **"Inquiry into the Impact of Road Safety Behaviours on Vulnerable Road Users"** Report by Legislative Assembly Economy and Infrastructure Committee in May 2024.
- Created tailored bi-annual newsletters for key stakeholders, including VicPol, FRV and Councils.

- Participated in a Parliamentary Inquiry into the impact of road safety behaviours on vulnerable road users
- Contributed to consultations on the Victorian Government's proposed gig economy Standards.
- CEO Brad Crofts was in regular dialogue with a range of road safety stakeholders, including TAC, Department of Transport and Planning on the GLI funding and the TAC Work Smart Drive Smart pilot.
- Re-affirmed the relationship with BlueScope Western Port to support all schools who participate in the F2D Workshop on the Mornington Peninsula.
- Deepen engagement with current stakeholders, VicPol and FRV.



Financial Sustainability

A) STRENGTHEN COMMUNITY SPONSORSHIP AND PATRONAGE

- The Foundation continues to maintain positive and productive relationships with 20 funding bodies, including local Councils and community associations.
- We received funding of \$10,000 from the Department of Transport and Planning to support the implementation of the GLI program for CALD communities.
- Fit to Drive has submitted the application to the Australian Charities and not-for profit Commission and **successfully achieved the charity status** by the end of 2024 financial year.

B) SECURE PUBLIC SECTOR FUNDING


- TAC agreement to fund activities related to both the preparation for and the delivery of the road safety workplace pilot Work Smart Drive Smart.
- Explored additional state-based grants, eg, for the GLI and GLI (CALD) from the Department of Transport and Planning.
- The transitioning to the developing Revised F2D Program in 2025 will assist us in our work towards a self-funding model for F2D Workshops. With a reduced number of facilitators needed, and reduced logistical time required, this will reduce the costs involved, which therefore reduces the cost to schools and funding bodies. This may in turn increase our bookings and delivery of the program, increasing our reach to students across Victoria.


